## What are refunding bonds?

Refunding bonds provide public entities like POCID a mechanism to restructure debt or save money by issuing new bonds at lower interest rates. In order to utilize this cost-saving mechanism in the District voters must approve the refunding of bonds. Districts generally refund existing or "outstanding" bonds when their financial advisor provides them with the opportunity to do so, as allowed by law, and when the Board of Directors determines that it makes sense to do so in order to save money. It is helpful to think of refunding bonds in terms of refinancing a mortgage. If your existing loan has higher interest rates and the interest rates drop, then you might refinance your home loan to take advantage of the lower rates and save money. This is similar to what refunding bonds allow the District to do with existing or outstanding bonds.

Has Port O'Connor Improvement District ever issued refunding bonds?

Yes. In 2013, the District used refunding bonds to restructure debt by converting high cost revenue bonds into tax bonds with a more favorable interest rate. This decision resulted in a Net PV Savings of \$394,440.01 to the District.

## ¿Qué son los bonos de reembolso?

Los bonos de reembolso proporcionan a organismos públicos como POCID un mecanismo para reestructurar la deuda o ahorrar dinero mediante la emisión de nuevos bonos a tasas de interés más bajas. Para poder utilizar este mecanismo que ahorra dinero en el Distrito, los votantes deben aprobar los bonos de reembolso. Los distritos generalmente reembolsan bonos existentes o "pendientes" cuando sus asesores financieros les ofrece la oportunidad de hacerlo, según lo permita la ley, y cuando la Junta Directiva determina que tiene sentido hacerlo para poder ahorrar dinero. Ayuda pensar en los bonos de reembolso como la refinanciación de una hipoteca. Si su préstamo actual tiene una tasa de interés alta y las tasas de interés bajan, entonces usted podría querer refinanciar el préstamo de su casa para aprovechar las tasas más bajas y así ahorrar dinero. Esto es parecido a lo que los bonos de reembolso le permiten hacer al Distrito con los bonos existentes o pendientes.

¿El Distrito de Mejoras de Port O'Connor ha emitido bonos de reembolso alguna vez?

Sí. En el año 2013, el Distrito utilizó bonos de reembolso para reestructurar deuda convirtiendo bonos de ingresos de alto costo en bonos de impuestos con una tasa de interés más favorable. Esta decisión resultó en ahorros del VP neto de \$394,440.01 para el Distrito.

McCall Gibson Swedlund Barefoot PLLC performed an accountability audit of the District. The District has an audit performed every year. Auditors presented the results of the audit of fiscal year 2020-21 to the POCID board of directors on February 10, 2022.

The purpose of the audit is to ensure public funds are handled properly and transparently and that business is transacted in accordance with state laws. Auditors also look at internal controls and ensure that internal policies are being adhered to. When auditors discover improper transactions of business or procedures, they issue “findings” in their report and follow up to make sure corrections are made.




## ***Smoke Testing***

**If there is a problem with infiltration into the sanitary sewer system at your property you will receive a letter with a picture of the issue. The issue will be marked in orange paint and needs to be corrected within fifteen (15) days.**

## **Irrigation Permits**

All sprinkler systems require a permit completed and turned in to the POCID Office **before** installation. After installation a backflow inspection is required.



***ALL Outdoor Showers and fish cleaning stations need a permit & an inspection per District Policy. We are actively identifying these to insure we do not have an excess of rainwater in our sewer system. The smoke testing will help us with these. Please call the District office @ 361-983-2652 to obtain the required permit.***
