## MINUTES Special Meeting of Board of Directors Thursday, October 18, 2018 at 1:00 p.m.

The Board of Directors of the Port O'Connor Improvement District ("POCID") held a Special Meeting on Thursday, October 18, 2018, at 1:00 p.m. at the District Office, 39 Denman Drive, Port O'Connor, Texas.

A. CALL TO ORDER. Leon Brown called the meeting to order at 1:00 p.m. and announced that a quorum was present and welcomed citizens.

Bond Counsel explained the resolution to approve the form of the Preliminary Statement and Notice of Sale and authorized the Board President along with the Financial Advisor, Bond Counsel, Disclosure Counsel, General Counsel and other POCID consultants to finalize the documents. The Financial Advisor explained the documents and the

information contained within the documents. The interest rate is a fixed rate. He also explained the advertisement for the Notice of Sale.

and (b) to authorize Bond Counsel with assistance of Financial Advisors, Disclosure Counsel, General Counsel and other POCID consultants to make necessary changes for bond compliance.

4. Consider and approve designation of Paying Agent/Registrar in connection with the Unlimited Tax Bonds, Series 2018.

The Paying Agent/Registrar is The Bank of New York Mellon Trust Co., same paying agenda/registrar as for outstanding bonds. – documents were included in the packet.
